On the recommendation of Bihar State University Service Commission, Patna under the provisions contained in the Statutes (duly approved by the Chancellor of the Universities of Bihar vide Notification Memo No-BSU.25/2014-1472/GS(1) dated-10.08.2020) for appointment of Assistant Professors in the Universities of Bihar and communicated to the Patna University by Higher Education, Education Department, Government of Bihar vide its Letter No-19/22-20/2025-822 Dated-15.12.2025, the below named candidates, on the approval of the meeting of Syndicate dated-28.01.2026 is appointed as Assistant Professor against the vacant post in the subject of **Political Science (Faculty of Social Science)** under Patna University Service, Patna on temporary basis in the pay scale of Rs.57700/- to Rs.182400/- (Academic Pay Level-10) with all admissible allowances as per rules of Patna University w.e.f. the date they join their duties. The above mentioned candidates will submit their joining along with all the required documents within 15 days from the issue of this Notification to their respective place of posting mentioned above. In case any selected candidate is already in employment, they are required to submit their relieving certificate in original from their respective employer along with the joining letter. During the course of their employment in Patna University, if any of their certificates are found fake/tampered at any stage, their appointment is liable to be cancelled.

The above mentioned candidates will be governed by New Pension Scheme and have to abide by the provisions of Service Statute of the Patna University, Patna. No T.A/D.A. shall be paid for joining the post. As per direction of the Higher Education, Education Department, Government of Bihar received vide aforesaid letter, it is pertinent to mention that the result of successful candidates named above will be affected by the final order judgements of the cases pending before the Hon'ble Patna High Court in this regard. The above mentioned candidates have to submit a declaration of 1st Class Judicial Magistrate in the format at the time of joining which is attached with the notification.
