



Reference is invited to this Secretariat's letter No.-BSU(UGC)-02/2023-687/GS(I), dated-15.05.2023, vide which Ordinance and Regulations for the Bachelor of Arts / Science / Commerce (Honours) 4-Year Programme under Choice Based Credit System (CBCS) and Semester System as per UGC Regulation (Curriculum and Credit Framework for Undergraduate Programmes) has been promulgated for its introduction in the Universities of Bihar from the session 2023-2027 onwards.

In this regard, curriculum of 42 Subjects of remaining six semesters have been finalized which were prepared by the Subject Experts.

Accordingly, the Hon'ble Chancellor after due consideration has approved the syllabus of 42 subjects of Choice Based Credit System (CBCS) and Semester System as per UGC Regulation (Curriculum and Credit Framework for Undergraduate Programmes) for remaining six Semester and has also approved the following recommendation of the syllabus committee:-

1. *'India The Mother of Democracy'* - to be included in the basket of Value Added Course of Semester-2.
2. *Modern Indian Language (MIL)*- The concerned University may float and prepare the syllabus of Modern Indian Language which are not available on the website of Raj Bhavan and shall get it approved by the Academic Council of the University under intimation to Governor's Secretariat.
3. *Multidisciplinary Course (MDC)*- while choosing the MDC subject the candidate have to choose that subject which he has not opted in Major & Minor subject.
