



The Grievance Committee took up all the grievances (713 grievances) and after thorough discussion among the members, the following decisions were taken and resolved to redress online grievances of the students:





Grievance Redressal :

Nature of Grievances:-


Hostel problems - Waiting for Government's directives in this regard.

Cancellation of Examinations - The matter has already been decided by University administration as below:


- 1) All the P.G. students are allowed to take up their classes and promoted to Sem III from Sem II subject to their passing out in Sem II examination by appearing at the examination on the date and time which shall be fixed by the University administration in due course of time. In any case, it is decided by the University that the students at the P.G. level shall not be promoted on the basis of their internal assessment. Appearance at the final year examinations is mandatory as per the U.G.C. directives and as per the decisions of the Apex's court.
- 2) So far as undergraduate (UG) final examinations are concerned, i.e. theory and practical both, the University administration has already decided to conduct the examination under reference by the third week of September, 2020. The date of examination has already been fixed by the University from September 21, 2020. The under graduate

- 3) So far as the completion of syllabus is concerned, the following guidelines may be followed: -
- Classes through online in all subjects have been conducted by the concerned teachers of UG and PG both. Still it is going on. Hence. All students concerned are directed to contact with HOD/ Principal concerned.
 - e-contents have been uploaded. Contact numbers and e-mail IDs of the respective teachers have also been uploaded on the P.U. website. In case of any difficulties, regarding completion of syllabus and understanding of subjects, candidates are advised to contact the respective teachers on the contact numbers and e-mail IDs and the department concerned.
- 4) In addition to above Sl.No.-1, 2 & 3, the following grievances have also been taken-up by the committee.
- Regarding waiving – off tuition fees:
Resolved that the said grievance be sent to the competent authority for the needful.
 - Regarding delivery of degree of miss Suprita Dokania
Resolved that the grievance of Ms. Suprita Dokania may be referred to the Controller of Examinations for taking decision in the matter on priority basis.
 - Regarding Ph.D. Thesis writing and Plagiarism removal
The grievance committee expressed displeasure as to how such type of letter relating to writing Ph.D. thesis and removing Plagiarism is sent by one Vinayaka society to the grievance cell of Patna University.
The grievance committee has unanimously resolved to lodge an FIR against Vinayaka Society by Patna University for its fraudulent and unfair activities in the name of education and Research with Patna University.
 - Publication of final year result
Resolved that the matter may be referred to controller of examinations.
 - Admission in PG Course
Admission in PG course will be expedited after the declaration of B.A. or B.Sc. Part III examination result which has already been scheduled.
 - Ph.D. course work in English of 2019 batch
Resolved that the matter may be referred to the Dean, Faculty of Social Sciences, Patna University.
 - Result declaration
Resolved that the matter may be referred to the Controller of examinations.
 - UG Entrance Examination
