Notification

Research Policy

The University has a defined policy for the promotion of research and facilities as described in the following sub-heads:

1. Conduct of Ph.D. Admission Test (PAT) for the registration / admission of the candidates willing to undertake research in various subjects including the UGC/CSIR NET/JRF candidates. (Refer to Ph.D. Ordinance and Regulations)
2. Meeting of the Post-Graduate Research Council (PGRC) at regular intervals to scrutinize and approve research proposals for the award of the PhD Degree.
3. Allocation of funds for the purchase of instruments, apparatus and IT equipments for various departments and teachers from the sanctioned plan funds of the UGC.
4. Allocation of funds for travel grants for participating in conferences/seminars/workshops held abroad.
5. Allocation of funds for organizing International / National conferences / seminars / workshops to various Post Graduate Departments from UGC grants and University funds.
6. Publication of journals by different faculties printed by the Patna University Press.
7. Provision of dissertation work in the Post Graduate syllabi to inculcate research orientation in the students.
8. Provision of granting study leave / sabbatical leave for teachers for further studies and researches in other institutions.
9. Promotion of collaborative research with other Institutions / organizations across the country and the globe.
10. Provision of research promotion grant to teachers having research publications in the journals in the UGC list and other refereed/indexed journals of repute.

11. For the maintenance of the level of research, regular conduct of plagiarism checks for Ph.D. / D.Sc./ D.Litt. theses is undertaken by the University. For this purpose, the University has recently notified the Anti-Plagiarism Policy and Regulations, 2018.
12. Existence of Faculty-wise Research Advisory Committee (RAC) for the promotion of research in thrust areas and local issues.
13. Existence of research policy drafting committee for the formulation of policies to promote research and innovation.
14. Statutory provision for promotion of high level of research leading to the degree of D.Litt. and D.Sc. to well-deserved and eligible candidates.
15. Availability of some endowment funds, wherefrom fellowships/loan scholarships are provided to willing and eligible candidates.

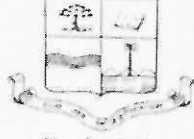

Sub.: Regarding Anti Plagiarism check of Ph.D. thesis.

Sir/Madam,

I am directed to forward the resolutions of meeting held on 27.02.2019 regarding the above mentioned subject:

The meeting was held under the Chairmanship of the Hon'ble Vice-Chancellor and resolved that the following procedure will be followed for Ph.D., D. Litt. and D.Sc. thesis.

1. The Supervisor will forward the thesis after getting fully satisfied with the research work of scholar in spiral binding alongwith a C.D. to be submitted to the Anti Plagiarism Cell, Patna University.
2. The Anti Plagiarism Cell will be responsible for through checking of thesis on 'URKUND'. A copy of the report, in sealed envelop alongwith the spiral bond copy of thesis be sent back to the Head of the concerned department. At the same time one copy of report will be sent to the Controller of Examination, Patna University and the other be given to the candidate.
3. On the basis of Plagiarism check report the Head will call a meeting of Departmental Council and if the thesis is found within the limit then Departmental Council will approve, otherwise advice the Research Scholar to act according to the provisions of the Patna University Anti-Plagiarism Policy.
- ✓ Once the thesis is approved by the Departmental Council for the Anti Plagiarism the candidate may be directed to give the Pre-Ph.D. presentation.
5. After clearing the Pre-Ph.D. presentation, Ph.D. thesis having Anti Plagiarism Certificate duly signed by the Head & Supervisor in each copy of the thesis will be submitted to the Examination Section.
6. The original copy of the Plagiarism check report duly signed by Supervisor and the concerned Head with the certificate of pre-submission viva and other documents as required previously be submitted with Ph.D. thesis to the Examination Section to ensure the transparency that the Ph.D. thesis has the same content which was submitted for Plagiarism check.

7. Once Departmental Council approves the research work, the scholar will attach following documents in the thesis
 1. Supervisor report/ certificate
 2. Head certificate/report
 3. Plagiarism Verification Certificate – Annex. I
 4. Self declaration – Annx. II
 5. Self Plagiarism exclusion certificate from Supervisor – Annex. III
 6. Self Plagiarism co authors certificate – Annex. IV.
8. Those thesis having Plagiarism report above 20% will also be discussed in Departmental Council. The Departmental Council will advice, instruct and suggest the required modification in the thesis to the candidate.
9. The committee further resolved that above procedure will be followed from 11th March and in between no thesis will be forwarded (from 1st March to 10 March).
10. The Committee resolved that the thesis in Urdu language is exempted from Anti Plagiarism check till the software is available. However, the supervisor and scholar will examine the thesis thoroughly and the scholar will submit certificate of originality. If the thesis is found to be plagiarised later on at any stage then necessary action will be taken as per Patna University Anti Plagiarism Policy and Regulations.
