Patna University : A Brief Profile

The seventh oldest university and the first in Bihar, Patna University was founded by an Act of legislature on the 1st of October 1917. The University was established as an examining body and conducted examinations from matriculation to post graduation. Its jurisdiction mapped Bihar, Orissa and Nepal and for forty years since its inception Patna University was the arbiter of the academic destiny of these territories. The Patna University Act, 1951, which received the assent of the Honorable Governor on the 6th of July 1951, was passed with a view to establishing a Teaching and Residential University at Patna. The Act defines that the purpose and powers of the university shall be to provide instruction in such branches of learning as the University may think fit

including professional studies and technology, and for research and for the advancement and dissemination of knowledge. It remained the only university in Bihar until January 1952 and continued to be the examining body of educational institutions in Nepal until the founding of Tribhuvan University in Kathmandu. With the founding of Utkal University this university ceased to be the examining body for institutions in Orissa.

The history of Patna University parallels the history of the educational, cultural, political and economic growth of modern Bihar. It is the only teaching cum residential university in the state with a truly national character that transcends linguistic, cultural, political and other denominational boundaries. The outstanding personalities who have led India's



Freedom Struggle and have occupied or are now occupying coveted academic, administrative, judicial and political position along with its reputed teachers and brilliant students have largely contributed towards its extremely rich academic heritage. Bihar has been an ancient seat of learning. Within its territory famous universities such as Nalanda and Vikramshila had once drawn students, teachers and scholars from various parts of Asia.

After independence, higher education being a major resource for economic progress and social transformation had to be popularized for the growth and development of the state. At that time it was felt that Patna University with its sound infrastructure ought to better concentrate on scholarship, teaching and research and divest itself of the responsibility of conducting various state level examinations.

Today, Patna University has ten constituent colleges, Patna College, Patna Science College, B.N. College, Patna Law College, Magadh Mahila College, Patna Women's College, Vanijya Mahavidyalaya, College of Arts and Craft, Patna Training College, Patna Women's Training College and thirty-one post-graduate departments in the faculties of Humanities, Social Science, Science, Education, Commerce, Law and Management, (and ten constituent colleges aside of the Faculty of Medicine that is administered by the stated government) Most of the post - graduate departments are located

in Darbhanga Raj buildings that are a part of a distinguished architectural heritage of the state. Constituent colleges of Patna University such as Magadh Mahila College, Patna College, B.N. College, Patna Women's College and Vanijya Mahavidyalaya, run post-graduate departments as well in select subjects. These courses fulfil the increased public demand for access to post-graduate study.

The University is in the process of revitalizing its potential for excellence to provide students, researchers and teachers opportunities to excel in their disciplines and establish partnerships with Indian and off-shore universities to enhance scholarship and sharing of technology. The UGC Academic Staff College, now UGC Human Resource Development Centre, through orientation and refresher courses, seminars and workshops reminds the academic community of the need to update knowledge and refurbish teaching and communication skills

Located centrally, at the hub of the university campus, is the Central Library that meets the needs of students, teachers, and research scholars alike. The computerized library is connected to INFLIBNET. Users can access four hundred thousand books, eighty-seven periodicals, fifty thousand back issues of journal and more than five thousand rare manuscripts.

In an age of information and communication technology the frontiers of time and space are ever expanding and the University is in the



process of equipping teachers and students with contemporary techniques, skill and knowledge of face various professional challenges. Of the ten constituent colleges, three are exclusively meant for women students while in the other co-educational institutions including post graduate departments the number of women students is quite substantial. Patna University has always been sensitive to the needs of the socially and economically disadvantaged, the students with special needs. It has strictly followed the reservation policy of the government thus enabling them to translate their fast potential into concrete achievement. For co-curricular participation and holistic development of

student, agencies such as the NSS, NCC, Sports and Cultural Activities Boards and numerous learned Societies encourage these talents. Many of our students have performed with great distinction at university, state and national levels.

The Post Graduate Department of Persian, Patna University is one of the oldest departments of the University and is presently being headed by Dr. Sufia Nasreen. It was established in the year 1917 with the inception of the university. The first batch of students came out successfully in 1919. Department of History

The Department of History, Patna University is one of the most renowned Department of Social Sciences in the country. The post-graduate teaching in History started in Patna College in 1910. In the year 1952 the Post-Graduate History Department was split into two Departments viz. The Department of History and the Department of Ancient Indian History and Archaeology.

The Department of History shifted from the Patna College in 1952 under the headship of Professor K.K. Datta and the Department of Ancient Indian History and Culture under the headship of Professor A.S. Altekar.

The teachers of the Department attained international fame. Prof. K.K. Data, Prof. S.H. Askari, Prof. R.S. Sharma, Prof. J.N. Sarkar, Prof. Yogendra Mishra, Prof. B.P. Mazumdar, Prof. Qeyamuddin Ahmad, Prof. V.A. Narain, Prof. J.C. Jha and Prof. S. Gopal enhanced the prestige of the Department. Their teaching and research contributed immensely to the development of Indian historiography.

Prof. Bimal Prasad, Prof. R.S. Sharma, Prof. Subira Jaiswal, Prof. R.L. Shukla and Prof. D.N. Jha of this Department later joined the faculty of the Jawaharlal Nehru University and Delhi University.

The Department also had on its faculty, scholars like Prof. Papiya Ghosh and Prof. V.K. Thakur. Thus the Department can boast

of being an excellent centre of research and teaching of history of different areas.

The achievements of the Department was duly acknowledged by the University Grants Commission. The Department was granted Special Assistance Programme by the U.G.C. in 1972 to promote research in regional history and other academic activities. The programme was renewed twice. Under this programme various projects were completed and a host of nationally and internationally reputed scholars visited the Department. Mention may be made of Prof. A.L. Basham, Prof. NilKanth Sastri, Prof. D.C. Sirkar, Prof. Syed Nurul Hasan, Prof. Bipan Chandra, Prof. Irfan Habib and Prof. Romila Thapar in this regard. Prof. E.T. Embree, Prof. A.S. Walport and Prof. Walter Hauser also visited the Department. Prof. Bharti S. Kumar became the first woman Head of the Department in 2009.

The Department of History, Patna University offers Master of Arts curriculum in History with five specializations namely Ancient Indian History, Medieval Indian History, Modern Indian History, International Relations and Peninsular Indian History.

The Department started Post-Graduate Diploma course in Women's Studies in 2007 which has been finally upgraded as an independent Department of Women's Studies Under the stewardship of Prof. Kameshwar



Pd., Head of History Department. Prof. Bharti S. Kumar was the founder Co-ordinator of this course.

The Department of History is one the most well known departments in the faculty of Social Sciences.

Established in 1952 the History Department like the Oxford University follows an integrated time-table for under graduate and Post graduate classes.

The Department follows the Semester System spread over four semesters. The first three semesters contain core papers which are common to all the students while the last semester is for optional specialized papers as well as a dissertation paper.

Continuous Internal Assessment (CIA) has also been incorporated to rationalize students' performance. The Syllabus has also been upgraded with addition of few new papers like Science and Technology in Indian History, Contemporary India and South Asia.

About 10 Refresher Courses sponsored by the U.G.C. have been conducted by the Department and lecturers from different parts of the country have benefited with latest research activities in the field of history. The Department also organizes V.A. Narain Memorial Lecture and Papiya Ghosh Memorial Lecture regularly.

To celebrate Centenary Year of Patna University, the Department decided to organize a series of memorial lectures to

commemorate the memories of the esteemed teachers of the Department.

A number of U.G.C. sponsored seminars and other seminars have also been organized by the Department.

About 125 to 130 students are enrolled every year.

The Department has an excellent Library which has more than fifty thousand books and a number of reputed journals at its disposal. The Department has also decided to publish the 'Journal of Historical Studies' during this year.

Besides teaching, the Department has also excelled in research work. Every year about forty students get enrolled for the Ph.D research work. The Department has the distinction of producing many internationally acknowledged Ph.D works.

The present faculty of the Department is also engaged in both teaching and research work and many of them have earned recognition in their field of research.

Department of Ancient Indian History and Archaeology

The Postgraduate Department of Ancient Indian History and Archaeology was established in November 1949. The Department was established under the renowned historian and archaeologist, Dr. A. S. Altekar, who also served as the Head of Department of Ancient Indian History and Culture at Banaras Hindu University and Director of Kashi Prasad Jayaswal Research Institute. Since 1953-54, teaching in degree classes of both Pass and Honours standard was centralized in the Department. In 1959-60 academic session the study of Archaeology was introduced in the Post-Graduate classes with the help of grants received from the University Grants Commission and the name of the department was changed to Ancient Indian History and Archaeology. The Department conducts Bachelors, Masters and Ph.D programmes. The masters programme has 80 seats for students and offers 16 courses during the duration of the programme. A departmental museum consisting of archaeological discoveries found in excavations conducted by its faculty and students at Chirand, Patliputra, Vaishali, Sonpur, Antichak, Maner, etc from where various coins, antiquities, sculptures, paintings have been sourced for the museum. The Department has a rich library with 16,000 books and rare journals. It has the technical staff to train students in the field of

Archaeology. A new double storied building was constructed for the department and has its independent new building since the 1963-64 academic year. Prior to this, the Department was located at Darbhanga House. Practical knowledge in conducting archaeological excavations and explorations have been provided by the Department through field work. Some of the eminent teachers of the department have been Dr. B. P. Sinha, Dr. B. Sahay, Dr. B. P. Rai, Dr. O.P. Jaiswal etc.

The Department of Sociology started in Patna University in July, 1951 which was headed by an eminent political scientist, Prof. V. K. N. Menon. He was succeeded by an eminent sociologist, Prof. Narmadeshwar Prasad. The Department soon emerged as the most important centre for teaching and research in Sociology in the entire eastern

region of India. The department was privileged to host the Second All India Sociological Conference in 1956. The department attracted top most sociologists of the time such as Prof. M. N. Srinivas, Prof. S.C. Dubey, Prof. Yogendra Singh, Prof. R. K. Mukherjee, Prof. S. P. Nagendra, Prof. R. N. Saxena and Prof. S. K. Srivastava who frequented the department in varying



capacities. The students of the department have assumed very coveted positions in different walks of life and various academic institutions in India and abroad. For instance, Prof. Partha N. Mukherjee rose to the rank of Director, TISS, Mumbai and the President of the All India Sociological Society; Prof. M. N. Most of the teachers of Sociology in the states of Bihar and Jharkhand have been students of this department. With the enactment of the Factories Act 1948 and keeping in view its provisions relating to health, safety and welfare, appointment of Welfare Officer became mandatory on the part of the employer. The department was first in its kind which was started to provide specialized education and training to the students who were to seek jobs in the areas of industrial relations, labour welfare, Govt. labour departments of states and the entire other welfare agencies and careers in trade unions. It was the collective foresight of Sir C.P.N. Sinha, the then Vice-Chancellor of Patna University, Dr. Gorakh Nath Sinha, the then Head of Economics department and above all Late Sri Jagjivan Ram, the then Union Minister of Labour which brought the department as an academic specialized centre in 1948. The part time faculties included Dr. V.K.N. Menon, the then Head of Political Science, Dr. B.R. Mishra, the then Head of Applied Economics & Commerce, Dr. H.P. Maiti, the then Director of Psychological Research Institute, Dr.

Ramola Nandi, Principal of M.M. College. The other set included the names of Prof. B. Gopal, Prof. A.D. Singh, Prof. Durganand Sinha, Prof. Diwakar Jha, Dr. M.Z. Abidin, Dr. D.N. Lal and Dr. Namdeshwar Prasad of Sociology Department. Dr. G.P. Sinha was the founder Head of the Department. The subsequent heads were Prof. A.D. Singh, Dr. P.R.N. Sinha, Dr. S.M. Raza, Dr. B.N. Shukla, Dr. K.P. Singh, Dr. Geeta Sinha, Prof. Prabhakar Jha, Dr. Sharad Prawal, and now Dr. Sunita Roy. The other eminent faculties include Dr. B.B. Verma, Dr. R.K. Singh, Dr. R.P. Verma, late Prof. M. Lal, Dr. B.N. Singh and late Dr. K.C. Singh. All the teachers of the department had great academic capability and genuine research interests. The other teachers in the academic galaxy of the department are Dr. Sanjay Paswan, Dr. Govind Kumar and Dr. K. Pandit. The academic capability and research calibre of the teachers of the department are constantly manifested in various research activities, publications, workshops, seminars and conduct of



conferences of national and international repute. All the faculties retired and serving the Alma Mater are really the pride of the university duly known in and outside the country.

In the year 2006, the nomenclature of the Department was duly changed from Labour and Social Welfare to Personnel Management and Industrial Relations keeping in view the requirements of the job markets and changed character of the course. Since 1984 the department started two self financed courses namely Rural Management & Welfare Administration and Industrial Safety Management of the Diploma character due to increasing demand from the various sections. In 2000, the Rural Welfare Administration was converted into two year M.A. Course duly approved and recognized by the UGC and other agencies. Its ordinance & the regulations are approved by the Hon'ble Chancellor of Patna University. Department of Geography, P.U.

The Post-Graduate Department of Geography, Patna University, Patna was established in the year 1949 and is the 8th oldest Department in India. The Department of Geography, in general, is actually much older and was established in 1927-28 as a centre of graduate level teaching and is only the second oldest in the country after the Department of Geography, Aligarh Muslim University, Aligarh. The Department has been a leading center for quality education and research in Geography in the Post Independence era. At present, it is one of the oldest Departments in the country having a team of scholarly teachers and research fellows, and has also well-equipped laboratories and a very rich library with, more than 12,000 books, journals and

magazines. This Department had, for the first time in Bihar, carried out such projects related to environment and ecology, as the Damodar Valley Diagnostic Survey (1959-1965) in collaboration with the University of Calcutta and IIT, Kharagpur, Terrain Evaluation Survey (1969-72) sponsored by the Ministry of Defence, Govt. of India, Pollution Survey (1980-82) at the State Level sponsored by the Bihar State Pollution Control Board etc. The Department was included in the Special Assistance Programme (SAP) - DRS - I for carrying out research in the field of Urban Geography for the period 2010-15. The teachers of the Department, like Prof. P. Dayal, Prof. L N Ram, Prof. R. B. P. Singh, have served the highest administrative positions



including the President in the Association of Geographers, India. The teachers have contributed immensely to such modern and impactful studies as the interface of Geography and Slum Studies, the diminishing wetland of North Bihar, Political Geography in the Indian frontiers of Jammu and Kashmir etc.

Institute of Psychological Research & Services

The Institute of Psychological Research and Services (IPRS) is a post-graduate wing of the Patna University and is functioning since 1945. The objective of the institute is to conduct research and training in the field of Psychology and also provide psychological services to the students, teachers and other members of the society. The services rendered include vocational guidance, family counseling, marital counseling, psychotherapy to neurotic patients, and helping the rehabilitation of people who have undergone social, mental or physical trauma.

The Institute conducts the following two self-financing vocational courses :

Post-graduate Diploma in Clinical Psychology (PGDCP) : Students are trained to diagnose people with behavioural problems pertaining to their personal lives and those related to their families and others in the community. Apart from providing theoretical inputs through class lectures, the students are sent under the guidance of a regular faculty member to mental hospitals for practical training and participation in different programmes. In the recent past, two such hospitals, the Sanjivani Mental Hospital,

Phulwarisarif, Patna and the Ranchi Institute of Neuro-Psychiatry & Allied Sciences (RINPAS), Kanke, Ranchi have been selected for training. The institute has also attached itself with relevant department of the Patna Medical College and Hospital to diagnose cases and apply psychological tests on patients there.

1 Year 30 Post-graduate Diploma in Applied Criminology :

This is a job-oriented course of one year duration. This objective of the course is to impart specialized knowledge in Criminology. Besides the psychological dimension of criminal behaviour, the course exposes its students to other important dimensions of crime covering law, judicial practices, police administration, rehabilitation methods and the like.

There are three areas of research activities :



Department of Chemistry

The undergraduate wing of the Department of Chemistry was established in the Patna College in May, 1927 and the postgraduate wing of the Department was established in 1946 at the same place of Patna College, which was then shifted to the present Patna Science College building in 1952. From its inception, the department has maintained quality teaching and very high level of research activities. The P.G. Department of Chemistry was famous due to its teachers like Prof. R.C. Ray, Prof. P.C. Sinha, Prof. S.P. Ghosh, Prof. D.N. Ghosh, Prof. Balbhadra Prasad, Prof. J.N. Chatterji, Prof. Biltu Singh, Prof. A.K. Banerjee, Dr. D. Mandal, and Dr. N. K. Jha among others, many of whom became the members of the Indian Chemical Society, the American Chemical Society, and the Royal Chemical Society. Presently the department has maintained the spirit of its glory in teaching as well as in research. Prof. J. N. Chatterjea patented the synthesis of some perfumes and also synthesized Flavanoid compounds having medicinal values in the Departmental Laboratory in 1979-80. The medicines called Rabiflux and Rubiflux, which are still sold in the European markets for the treatment of Arthritis were initially developed in the Departmental Research Laboratory. The department has a very rich library with more than 10,000 books and around 2000 national and international

journals, like the Journal of Indian Chemical Society, the Journal of American Chemical Society, the Journal of German Chemical Society, the Journal of Chemistry etc. starting from 1870 onwards. Currently, the Department specializes in the fields like Physical Chemistry, Inorganic Chemistry and Organic Chemistry.

Establishment of an advanced centre for Chemical learning through updated laboratory techniques for the isolation, extraction and synthesis of compounds of organic and inorganic properties along with creating scientific awareness in students for resolving the socio-economic problems, which eventually will result in ensuring gainful employments by creating an environment conducive for research and development.

Department of Zoology

The Department of Zoology, initially established in 1948 to impart M.Sc. teaching and research under Patna Science College, got the status of the University Department in July 1952. Currently the Department has seven faculty members (three Professors, one Associate Professor and three Assistant Professors). The Department has a rich library with over 7000 books. Some important

journals are subscribed regularly. The Department has one M.Sc. Lecture Theatre, one M.Sc. Lab, one Seminar Hall and six well equipped research laboratories, and a good selection of specimens in Museum.

All the faculty members are engaged in research activities which are evident from the quality publications of the faculty and their active participation in symposia / seminars /



workshops etc. The department is carrying out advance research in the field of Genetic and molecular toxicology, aquatic toxicology, and environmental biology, limnology and conservation biology. Department of Botany

The Department of Botany, the first ever Post-Graduate Department of Botany in the State of Bihar, was established in July 1948, as an erstwhile part of Patna Science College. However, it attained the status of Postgraduate Department on 1st April, 1953. Since then, every attempt has been made to equip the Department for teaching, research and advance training.

The Department of Botany, Patna University has been an acclaimed centre in the Eastern as well as Northern region of the Country towards teaching and research in Cytogenetics and allied areas of Botany, since 1953 under the leadership of Late Prof. R. P. Roy, FNA. Due to its significant contributions in aforesaid areas, this Department was selected under SAP and COSIST programs of the UGC in the year 1976 and 1988, respectively.

A number of sophisticated instruments were procured for higher training and research in Cytogenetics and microbiology as well as other field of the subject. More than 500 research papers were published in the journals of National and International repute of the Department are regularly publishing research papers in National and International journals.

The Department, located in the building known as Statistics Block, is in the west of the Administrative Block of the Patna Science College. This Department of Statistics of the Patna University is the oldest in the State of Bihar and the fourth oldest in India.

The Department had carried out first ever demographic survey and population research by any academic department in the State of Bihar under the Headship of Prof. D. N. Lal.

The Department has produced many academicians and researchers, who are scattered in all over the world. It has also produced stalwarts, who became the Vice-Chancellors of different Universities and Administrative servants.

In 1966, a Population Research Centre (PRC) was established in the Department by the Ministry of Health and Family Welfare, Government of India with the Head of the Department of Statistics as its ex-officio Chief/Honorary Director. The center is fully funded by the Ministry of Health and Family Welfare, Government of India.

Undergraduate teaching in Geology in the Patna Science College commenced from July 1949.

Under the dynamic leadership of Dr. R. C. Sinha, who was appointed Tata Professor and Head of Geology in 1963, there was a rapid upsurge in both teaching and research activities. Dr. Sinha started teaching of Geochemistry in India and students from all parts of India took advantage of experimental research and training in Geochemistry. The Geochemical Society of India, was founded in 1965 in this department and it published journals and bulletins. The International Symposium on Recent Researches & Applications of Geochemistry organized by the Geology Department in 1973 witnessed international delegates from about 25 countries and a galaxy of earth scientists of the world participated. Later on, the department was selected for a Major Research Project on Santhal Parganas, Bihar.

In the seventies and eighties, the department received worldwide acclaim again especially through significant contributions in the fields of geochemistry and experimental mineralogy mainly by Dr. N.C.Ghose and Dr. A.P.Mall. Dr. N.C.Ghose was quite actively engaged in academic pursuit and earned a good reputation both nationally & internationally in the world of Geology. As a national representative of IGCP Projects he organized several Symposia & Conferences. The UGC selected the department under its Special Assistance Programme (SAP) in 2009.

Among the memorable alumni of the department who were trained in Geochemistry and excelled in their contributions were Dr. S.M Naqvi (INSA Fellow) and Dr. V.Divakara Rao, both from NGRI, Hyderabad and a host of Professors and Heads of the Departments in Earth Science in different Universities like Prof. G.S.Roonwal (Delhi), Prof. A.M.Patwardhan (Pune), Prof. A.N.Deshmukh (Nagpur), Prof. Y.P.Gupta (Jammu), Prof. J.C.V.Sastri (Mysore), Prof A. Surya Prakash Rao (Osmania) and many professors in the universities of Jharkhand.

In more recent times, many outstanding alumni like Pravin Verma and Anil Sharan (IFS), Rajiv Sinha and Manoj Singh (IAS), Ranjit Sinha, Rajni Kant



Mishra, Ram Chandra Sharma and Alok Raj (IPS), Prof. Rajiv Sinha (IIT, Kanpur) and Arbind Mitra (DST), Late Madhukar Anand (Kathak Dancer) have made us proud. An illustrious alumni Dr. Ranjan Prasad Yadav, Member of Parliament (Rajya Sabha), made a generous donation of funds to set up a state-of-the-art Museum-cum-Auditorium Complex in the premises. Besides these the department has produced eminent scholars who have served and also are leading organisations in India such as ONGC, GSI, CIL, CGWB, NMDC and AMD. Several alumni in the Geological Survey of India like S.P. Singh, R.N. Singh and R.R. Sharan, have contributed significantly in their projects or investigations and have received recognition in form of National Mineral Awards by the Government of India.

The Department of Geology imparts teaching both at under-graduate (B.Sc. Pass and Hons) and post-graduate levels, besides being actively engaged in research in different disciplines with the financial support from the U.G.C., Ministry of Environment & Forest, D.S.T. and Patna University.

Although the department has traditionally been in the forefront of hard & soft rock geochemistry and petrology, more recently the faculty has taken up research in aspects related to water pollution, ground water management, application of Remote Sensing & GIS and geomorphology. The department has been holding National seminars / workshops / training programmes at

regular intervals. Post-graduate students of the department undertake research projects (dissertation) on topics of geological significance as well as societal relevance. The department has already introduced semester system at the post-graduation level.

General Ordinance for Admission in the Various Courses of Studies of Patna University

1. The Vice - Chancellor shall have power to relax with the approval of the Chancellor any criteria and increase seats beyond the usual number of seats in the case of students (a) coming from foreign countries (b) nominated by the Government of Indian under various plan like the Colombo Plan etc. (c) coming under scheme of any daughters of Military personnel in active service / Ex-service Military personnel / Military personnel killed or disabled in action (e) who happen to be sons / daughters, wife/husbands of (i) teachers (including teachers of Medical and Dental colleges under the University), and (ii) Officers and other employees of the University upto a maximum of 5% of the total seats in the institutions and the courses concerned, except Medical, Dental and Engineering courses for each of the two categories (i) and (ii)

Provided that the Vice-Chancellor shall also have power to increase the seats with the approval of the Chancellor in case of teacher of the Patna University whether the number of seats allotted to their sons /

daughters / husband / wives fall short of 5% due to allotment of seats of sons / daughters / husbands / wives of teachers of Medical / Dental Colleges, who may have been selected for admission under this category within 5%

A Brief Glance of Patna University Library

The Patna University Library, established in 1919, was the seventh academic library of undivided India. Presently it is located in a specially designed spacious three-storied building constructed in 53, 250 sq. feet area, exclusively for the library, Dr. C. D. Deshmukh the then chairman of inaugurated this new library building on 17 Dec 1958, University Grants Commission, New Delhi. It has a rich collection of nearly 2-3 lac books, research journals, thesis and manuscripts in about 33 major and minor disciplines. It caters to the need of about 200-400 readers every day. It continues to be the core of research and other academic activities.

Keeping in consideration the contemporary need of the library users, the P.U. Library has been completely remoulded and air conditioned by the financial assistance received from the Department of Education, Govt. of Bihar. Subsequently, on the receipt of the grant of the UGC a big computer round o clock Internet connectivity through National Knowledge Network has also been installed.


The manuscript section of this library deserves special mention for having a collection of around 6000 (six thousand) valuable manuscripts encrypted on palm leaves, animal skin and woods etc. in Maithili, Bangla, Tibbetti, Brajbhasa, Tamil, Chinese,

Oriya, Sanksrit, Hindi, Nepali, Arabic, Persian and Urdu pertaining to the period from 14th century to 17 century AD. Some of the manuscripts are rare ones and of historic importance too. Important amongst them are : Saroj Kalika and Malti Madhvan of 14th century AD, Talinama, Risala Sifat Jaruriya of 15 century AC, Jahangirnama, Brihad Jatak, Khatmaye Ferhanse Jahangiri of 16th Century and Mashnavi Seen Khushro and Laila Majnu of 17th century AD. It is belived that the manuscripts on Laila Majnu is available only in P.U. Library in the world.

For the security reasons of inside and outside library premises, 30 CCTV cameras with recording facility have been installed. Towards un-interrupted power supply in the library a heavy-duty silent generator of 62.5 kV capacity is also installed.

The library remains open from 8:00 am to 8:00 pm (Monday to Saturday) for all the readers as well as to carry out all the administrative activities.

The complete Library automation project is currently going on, which will completely digitalize the library.

National Service Scheme



On September 24, 1969] the then Union Education Minister Dr. V.K.R.V. Rao, launched the NSS programme in 37 universities Covering all states and simultaneously requested the Chief Ministers of States for their cooperation and help. It was appropriate that the programme was started during the Gandhi Centenary Year as it was Gandhiji who inspired the Indian Youth to participate in the movement for Indian independence and the social uplift of the down-trodden masses of our nation.

The overall aim of National Service Scheme is to give an extension dimension to the higher education system and orient the student youth to community service while they are studying in education institution. The reason for the formulation of this objective is the general realisation that the college and +2 level students have a tendency to get alienated from the village / slum masses which constitute the majority of the population of the country. The educated youth who are expected to take the reins of administration in future are found to be unaware of the problems of the village / slum community and in certain cases are indifferent towards their needs and problems. Therefore it is necessary to arouse the social conscience of the students, and to provide them an opportunity to work with the people in the village and slums. It is felt that their interaction with the common villagers and slum dwellers will expose them to the realities of life and bring about a change in their social perception.

The board objectives of NSS are to :-

- (i) Understand the community in which they work;
- (ii) Understand themselves in relation to their community;
- (iii) Identify the needs and problems of the community and involve them in problem solving process;

- (iv) Develop among themselves a sense of social and civic responsibility;
- (v) Utilise their knowledge in finding practical solution to individual and community problems;
- (vi) Develop competence required for group-living and sharing of responsibilities;
- (vii) Gain skills in mobilising community participation;
- (viii) Acquire leadership qualities and democratic attitude;
- (ix) Develop capacity to meet emergencies and natural disasters and
- (x) Practice national integration and social harmony.

The Motto

The motto or watchword of the National Service Scheme is 'NOT ME BUT YOU'. This reflects the essence of democratic living and upholds the need for selfless service and appreciation of the other person's point of view and also to show consideration for fellow human beings. It underlines that the welfare of an individual is ultimately dependent on the welfare of society on the whole. Therefore, it should be the aim of the NSS to demonstrate this motto in its day-to-day programme.

NSS Symbol

The symbol of the National Service Scheme, is based on the 'Rath' wheel of the Konark Sun Temple situated in Orissa. These giant wheels of the Sun Temple portray the cycle of creation, preservation and release, and signify the movement in life across time and space. The design of the symbol, a simplified form of the Sun-chariot wheel primarily depicts movement. The wheel signifies the progressive cycle of life. It stands for continuity as well as change and implies the continuous striving of NSS for social transformation and upliftment.
