4. Eligibility criteria of the contractor participating in the tender:
  - (a) Registered contractor of Govt. of Bihar/C.P.W.D./ M.E.S. for appropriate category for civil & Electrical work. Working contractor of Patna University is only applicable for small work (up to ₹1,00,000) one lakh only.
  - (b) For new construction work, the agency should have past experience for same nature of work at list 50% of tender amount.
  - (c) As per amendment by resolution of Rule no. 159 (a) & 159 (b) of Public Works Code vide memo no. प्र0 7/नियम-01/2015/5931(5), Patna, dated 01/07/2015, 50% work will be reserved for SC, ST, EBC, BC and BC(Ladies) up to ₹ 15 Lacks of work value.
