Annexure-I
Amended General Regulations for Awarding Gold Medal to Ist class Ist rank
holder of PG and UG programmes (Both Regular and Self-financing)

Notwithstanding anything contrary to the existing Ordinances & Regulations of the Programmes concerned and in absence of specific provision in some of the Regulations, the Gold Medal will be awarded to the Ist class Ist rank holder of M.Lib.Sc., M.Ed. and LL.M. programmes. For other Post Graduate programmes where results are declared in CGPA, candidates having Ist class Ist with minimum 6.0 CGPA will be awarded Gold Medal.

Rank Certificate alongwith Gold medals shall be awarded to the candidates of the Regular as well as Self financing programmes of Undergraduate Programmes who have secured 1st class 1st Rank of the Subject / Programme / Course concerned with minimum 75% marks in aggregate. The candidates securing less than 75 marks in aggregate shall be awarded Rank Certificate to this effect only.

The following conditions will be fulfilled for awarding the 'Gold Medal':-

c. Must have completed the programme within the stipulated period. However, in case of late academic session or delayed publication of result, the Gold Medal shall be awarded, after the approval of the Hon'ble Chancellor, Universities of Bihar.

d. Should not have any proven record of disciplinary action during the programme.

The Gold Medals shall be awarded generally in the Annual Convocation or the event specifically arranged for the same.
