On the recommendation of Bihar State University Service Commission, Patna under the provisions contained in the Statutes (duly approved by the Chancellor of the Universities of Bihar vide notification memo no.BSU.25/2014-1472/GS(1) dated:10/08/2020) for appointment of Assistant Professors in the Universities of Bihar and communicated to the Patna University by Education Department, Government of Bihar vide its letter no-15/π 2-07/2021-794 dated:31/03/2022, the candidate, on approval of the Syndicate in its meeting dated:13/11/2024 at agenda no.SND-24.3.4., is appointed as Assistant Professor against the vacant post in the subject of Arabic (**Faculty of Humanities**) under Patna University Service, Patna on temporary basis in the pay scale of Rs.57700/- to Rs.182400/- (Academic Pay Level-10) with all admissible allowances as per rules of Patna University w.e.f. the date, they join their duties. He will have to submit relieving certificate in original, from his respective employers, provided he is in employment. In case, any of his certificates is found fake/tampered with at any stage, his appointment is liable to be cancelled.

He will be governed under New Pension Scheme and have to abide by the provisions of service statute of Patna University, Patna. This appointment will be affected by the order of Hon'ble Patna High Court in CWJC No.10294/2020, 10422/2020, 8932/2020 and other writ petitions for appointment to the post of Assistant Professor. No T.A./D.A. shall be paid for joining the post.
