Under the provisions contained in the Statutes (duly approved by the Chancellor of the Universities of Bihar vide notification memo no.BSU.25/2014-1472/GS(1) dated:10/08/2020 for the appointment of Assistant Professors in the Universities of Bihar and on the revised recommendation of Bihar State University Service Commission, Patna vide letter no.BSUSC/विज्ञान-55/2021-1922 dated:24/10/2024 communicated by the Director, Higher Education, Education Department, Government of Bihar, Patna to the Patna University vide its letter no-15/ पृ 2-19/2022-4983 dated:16/12/2024 and after duly approved by the Syndicate dated:13/01/2025 at its agenda no.25.1.6 of Patna University, the below mentioned candidate is appointed as Assistant Professor against the vacant post in the subject of Rural Studies (**Faculty of Social Sciences**) under Patna University Service, Patna on temporary basis in the pay scale of Rs.57700/- to Rs.182400/- (Academic Pay Level-10) with all admissible allowances as per rules of Patna University with the effect of her joining. The probation period will be of two years from the date she joins:-

The candidate is essentially required to submit her relieving certificate in original from her respective employers if already in employment. In case, any of her certificates submitted regarding her appointment is found fake/tampered, the appointment shall be liable to be cancelled. After appointment, she will be governed under New Pension Scheme and has to abide by the provisions of Service Statute of Patna University, Patna. No T.A./D.A. shall be paid for coming to joining the post.
