

Ability Enhancing Course-4
(The syllabus of Course on NGOs/Social Service/Sports (Health and Wellness) of Semester-IV (AEC-4))

• **NGOs:**

The student will also have the option to get working with registered NGOs preferably in the areas of Education / health / social service etc. in AEC-4 for minimum 30 hours volunteership. The evaluation report from the concerned NGOs will be considered for awarding the marks.

• **Social Service:**

The HEIs who have implemented the Unnat Bharat Abhiyan (UBA)/Goda Grama (GG) and are sending their students for social service under these schemes, will also be considered under AEC-4, provided that the students complete a minimum of 30 hours of service. 
