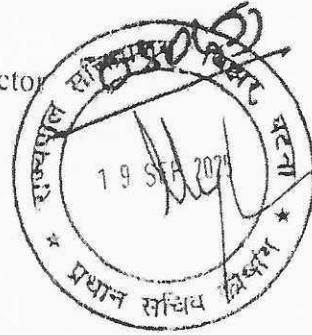

Sir,

The Bihar State Higher Education Council has been conferred with the power, as contained in section 11 (2)(v) of the Bihar State Higher Education Council Act, 2018 to "examine the statutes, ordinances and regulations of Universities in the State and suggest modifications to maintain uniformity in the administration without prejudice to the autonomy for the academic pursuits".

Patna University, Patna vide Letter No. Acad/106/AKS/1311 dated 04.09.2025 has sent a redrafted ordinance & regulations of B.B.A. LL.B 5 year (Integrated) (Hons.) Degree, a new programme at Patna Law College, Patna University.

The draft proposal has been examined by the three member committee of BSHEC. After examining the said proposal, it is observed that the council had earlier returned the proposal inter alia on the ground that the approval of the Bar Council of India had not been obtained by the Patna Law College, Patna University, Patna.

The Bar Council of India vide letter no. 3169 dated 25.08.2025 has granted the approval of affiliation to Patna Law College, Patna for imparting 5-years BBA LLB (H) integrated degree course with intake of three sections of 60 students in each section for the academic year 2025-26 subject to such conditions as imposed by the Inspection Team of Bar Council of India.

That apart, the captioned proposal has been approved by all the Statutory Bodies of the University in question.

Therefore, keeping in view the opinion of the Screening Committee and the comments of the Vice-Chairman, the captioned proposal may be considered for approval and the assent of the Hon'ble Chancellor may be accorded, subject to the provision contained in section 38 and 39 of the Patna University Act, 1976 (amended upto date).

Draft Ordinance for Admission to BBA, LL B (Integrated)  
(Five Years Degree Course)


1. Short Title and Commencement

The Present ordinance shall be called as "the Ordinance governing Admission, to BBA LL.B (Integrated) (Five Years Degree Course), through Centralized entrance tests and Commence on the date ; so notified by the Patna University.

2. Seats:

- i) The Total Number of Seats, in the BBA LLB (Integrated) Five Years Degree Course Shall be 60 [Sixty] subject to the approval of Bar Council of India.

3. Admissions

A. The admission to the BBA LL.B -(Integrated) Five Years Degree Course shall strictly be on the bases of merit list of the marks secured by the candidate in the Patna Law College Admission Test [PLCAT], to be conducted for the same by the Patna University in its various centers at Patna, Bihar,

B. The detailed program for PLCAT shall be published each year by the Patna University subject to approval of extension of affiliation of the said Course by the Bar Council of India.

4. Age Criteria for Admission:

The candidates applying for the above course shall not be more than 20 years of age as on the date of notification for admission to the Course is issued. However, the upper age limit shall be relaxed to two years for the candidates belonging to the SC, ST, & O.B.C.

5. Eligibility for admission:

A. The admission in BBA LLB (Integrated) Five Years Degree Course, through 'Entrance Examination', shall be open to all those candidates having passed their Intermediate [+ 2] examination from any of the Examination Boards, which have been recognized by the Central Government for the same or possessing such academic qualification as

B. However relaxation of 05 % of marks shall be available to all the SC, ST, and the Physically Indifferent candidates.

C. Appearing candidates in the Intermediate [+ 2] examination of any Board, as mentioned above, are also eligible to apply for the 'Entrance Test' subject to the condition that their Examination result of Intermediate [+2] should have been declared before the date of admission to the BBA LL.B- Part-I;

6. Selection Process:

A. Entrance Examination for the aforesaid Course shall be of 100 marks. Every candidate is required to secure a minimum of 45% marks in the entrance test so as to become eligible for admission to the BBA LL.B (Integrated) Five Years Degree [PART-I] Course;

B. Admission to the BBA LL.B (Integrated) Five Years Degree Course [PART-I] Course shall strictly on the basis of **MERIT LIST** prepared on the basis of total marks secured by the candidates at the aforesaid Admission Test being conducted by the Patna University for the same.

6A. Medium of Entrance Test

The medium of entrance test for the BBA LL.B(Integrated) Five Years Degree [PART-1] Course shall be of English / Hindi

7. Pattern of Entrance Test:

- a) The Entrance Test for the aforesaid Course shall comprise of one paper carrying 100 marks. The paper shall be comprised of Multiple Choice Questions (MCQ) covering areas of General Knowledge, General Science, Legal and Managerial Aptitude, And General English. The standard of questions shall be that of intermediate level and is aimed to judge the standard academic aptitude of the candidates for the said Course.
- b) There shall NOT be any negative marks deducted for the wrong answers.

8. Conditions For Admission:

- I. The candidate has to fill up the form through on-line process or as per directions of the Panna University for the same.

II. The selected candidate has to produce the following documents at the time of admission:-

A. Duly certified transcript of the scholastic record of the candidate, commencing from the matriculation to that of qualifying degree.

B. Original Transfer Certificate;

C. Original Migration Certificate or Equivalent

Provided further that if a candidate is unable to produce any of the aforesaid requisite documents, other than the mark-sheet of the Intermediate Examination at the time of admission in the Patna Law College for the said Course, he shall have to undertake submitting them within a reasonable time or within such further period as the Principal, Patna Law College may prescribe. And admission, if any, of such candidate shall, until the submission of the aforesaid requisite documents, deemed to be provisional.

III. The admission of a student in the aforesaid Course shall liable to be cancelled at any point of time in the event of his express breaching of any of the conditionality of the undertaking given by him / his/her parent or guardian, as the case may be

9. Other Conditions for Admission:

- i. In no case, a candidate will be eligible for admission to the BBA LL.B Course of the Patna Law College on the basis of TRANSFER CERTIFICATE from any other institution imparting LL. B Degree. Course.
- ii. Students who have already admitted to the BBA LLB (Integrated) Five Years Degree [PART-I] Course at Patna Law College shall not be permitted to pursue any other Course such as Master's or Diploma Course simultaneously subject to the amendments made by the BCI relating to any exemptions in the aforesaid provision.
- iii. There shall not be any Lateral Entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the present double degree integrated Course, at any of its intermediary stage
- iv. The Patna University reserves the liberty to refuse admission to anyone, with proved criminal background, without assigning any further reason in public interest or in the academic interest of the University itself.

10. Screening Procedures of the Admission:

- i) Unless otherwise prescribed by the Patna University Academic Council or any of the Orders from the concerned appropriate Bodies of Patna University, the number of students being admitted to its BBA LLB (Integrated) Five Years Degree [PART-I] Course shall not be more than 60 (SIXTY).
- ii) Candidates shall be admitted strictly in order of merit as determined on the basis of total marks obtained by him at the Qualifying Examination, Entrance Tests, and any of those other criterions as may be laid down from time to time;
- iii) In case the aggregate percentage of total marks obtained by the candidates at the Entrance Test are equal, then preference shall be given to candidate having higher marks in his qualifying examination.
- iv) However, in such cases where the marks of the candidates at both the above stated level happens to be equal, then the candidate who is senior in his age in compare to other claimant shall be given preference for admission to the said Course.

12. Duration of the Course and Semester System

- i) The duration of the course shall be Five Academic Years.
- ii) Each Academic Year shall be divided into Two Semesters.
- iii) Each Semester shall comprised of a minimum of Eighteen Weeks with not less than 30 class hours per week including Tutorials, Moot-Court Room Exercises, Written Tests, presentation of Project Works or assignments, Seminars, and any other academic activities undertaken in the student's interests.
- iv) In case of the Honours Law Courses, that begins from the Semester Nine onwards, there shall be a minimum of 36 class hours per week including those of Tutorials, Moot-Court Room Exercises, Written Tests, presentation of Project Works or assignments, Seminars, and any other academic activities undertaken towards furthering the future prospects of the student's professional or allied career.
- v) The Academic Session shall extend from the day of reopening of the University after summer vacations to the last working day of the concerned Academic Session. As such, the Academic Session for the First, Third, Fifth, Seventh And Ninth Semester shall ordinarily extend from the day of reopening of the University after summer vacations to the last week of December as the case may be.

vi) The Second, Fourth, Sixth, Eight and Tenth Semester shall ordinarily extend from the first week of January to the last working day of the concerned Academic Year/ Commencement of Summer Vacation as the case may be.

13. Curriculum of studies:

- i) The curriculum of study for the BBA LLB (Integrated) Five Years Degree Course shall comprise of the courses that have been set out in Schedule-A
- ii) The content of the Course of study for the aforesaid Course shall be in accordance to the one that have been set out in Schedule- B
- iii) It shall further be provided that the 'Board of Courses studies in Law' may make such changes in the contents of the Course of Study as and when it deem necessary and subsequently report the matter to the 'Academic Council', Patna University
- iv) A student admitted to the BBA LLB (Integrated) Five Years Degree Course, at the Patna Law College, shall require pursuing it in a regular manner attending requisite number of its classes in each Semester in order to be eligible to appear in the University Examinations being conducted by the university for the same.

vi) A student admitted to the aforesaid BBA LLB (Integrated) Five Years Degree Course shall have to take a total of Forty Eight [48] Papers (Subjects). Out of it, Twenty Papers shall be for that of the Management stream. The Law Paper shall be comprised of Eighteen (18) Compulsory Papers; Four (4) Clinical Papers and Six (6) Optional Papers from amongst the given list for the same.

vii) It may also include any of the other Additional Papers that may be prescribed by the University from time to time as per the need so arise for the same.

viii) The Names of the Paper Scheduled to be taught in any Semester of the aforesaid Course and the Detailed Syllabus for the same shall be given respectively under the **Schedule A and B** of this regulation.

15. TEACHING METHODS:

- i) The teaching methods at the undergraduate level shall aim at promoting of the inter-disciplinary approach and practical appreciation of the socio-legal & professional problems before hand. In addition to the lecture method, seminars, tutorials, assignments, clinical experience, fieldwork, legal research and legal writing will also be used.
- ii) In such Courses of the aforesaid Program requiring specialized teaching, guest faculties and experts in the concerned area of discipline shall be involved so as to maximize the learning potential of the students.
- iii) Clinical legal education shall also be given due place and academic credit will also be accredited to the students participating in it
- iv) The Principal, Patna Law College, Patna University shall be authorized to take any decisions regarding teaching of any optional subjects/ subject and Honours Papers in consultation with the members of the Academic Faculty.

16. ATTENDANCE

- i) Every students admitted to the BBA LLB (Integrated) Five Years Degree Course, at the Patna Law College, Patna University, shall be compulsorily required to attend at least a minimum of 75% of the total number of Lectures, so delivered, in each of the Subjects including those of Moot Courts, Tutorials, Seminars and Project or other assignment works.
- ii) Students admitted to the aforesaid Course having attended less than 75% but more than 60 % of the Classes so undertaken in any Semester may be allowed, as per the general provisions of the Patna University Regulations, to appear at the University Examination being conducted for the same.
- iii) A total number of 90 (Ninety) Lectures shall be delivered in a subject or a group of subjects forming a Separate Paper in the aforesaid Course. It includes those of Moot Courts, Tutorials, Seminars and Project or other assignment works.
- iv) Moot Courts, Tutorials, Seminars and Project or other assignment works etc. shall be conducted in each Semesters as per the periodic Guidelines issues by the Bar Council of India (BCI) New Delhi.

1. Short Title and Commencement

The Present ordinance shall be called as "the Ordinance governing Admission, to BBA LL.B (Integrated) (Five Years Degree Course), at Patna Law College, Patna University, and will commence on date so notified by the Patna University for the same.

2. Conduct of the University Examinations:

- i) Patna University shall conduct its University Examinations for the BBA LL.B (Integrated) Degree Courses, to be conducted at the Patna Law College or at any Centre of Patna University as per the convenience of Examination Department of the University itself.
- ii) The result for the Examination shall be published, by the Patna University, within a period of 30 days after the conduct of such Examinations.
- iii) No student shall be allowed to appear at the BBA LL.B Part-I Semester Examinations of Patna University unless he has been declared Sent-Up for the said Examination;

3. Promotion Schedule for the Examination:

- ii) A Second Semester student, of the BBA LL.B Part-I, appearing at the Examinations shall be promoted to the Third Semester of the said Course. But no student shall be permitted to appear in the Term-End Examinations of its Seventh Semester unless he has passed in at least Three Papers of the Sixth Semester Examinations and has also been subsequently declared Sent-Up for in the Seventh Semester Examinations of the said Course.
- vii) A Seventh Semester student, of the BBA LL.B Part-IV, appearing at the Examinations shall be promoted to the Eighth Semester of the said Course. But no student shall be permitted to



any Semester shall be allowed to appear in the following next year End Term Examination of the respective Semester so as to enable them clearing their Paper/Papers of the aforesaid Course

xi) In the event of occurring a gap of more than three Academic years after taking admission in the said B.B.A. LL.B.) [Integrated] Degree Course, the student shall be required to take fresh admission to the Course, irrespective of the fact that he / she has been declared Sent -Up for any of its Examinations conducted by the Patna University.

4. Supplementary Examinations:

- i) The Patna University shall hold a supplementary Examinations within 30 days of the End -Term Examinations for those candidates who either failed or were absent in IX<sup>th</sup> or X<sup>th</sup> Semester of the aforesaid BBA LL.B (Integrated) Degree Course of the Patna Law College, in order to provide them with an opportunity to clear such of their Paper/Papers.

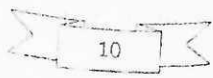

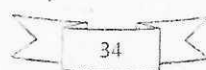
